### Legislative –.

Steve Brubaker sent in his report and Tony read and commented from it. Senate Cullerton's replacement is likely to be either Senator Lightford or Senator Harmon. More troubling stories, this time from the Senate GOP on gaming related issues. Both chambers will return to Springfield on Jan. 28. Steve has been in contact with other locations who are seeking a casino license. Illinois Gaming Board has not announced licenses or rulemakings for the various items contained in the gaming expansion law.

### GrassRoots and Membership -

Membership renewals for 2020 have been sent out and so far, within the first week, about 100 have been returned.

### Race Track Condition and Backstretch -
