 The horses with the ten highest points that enter, shall compete in the finals.  
 Ties shall be broke by draw.  
 Owners and/or trainers shall be limited to two (2) horses in the finals.  
 Horses are eligible to be claimed in each of the two legs as follows:  
 The first start for a horse in the series the claiming price shall be the advertised base claiming price (plus allowances)  
 The second start for a horse in the series the claiming price shall be 25% higher than the advertised base claiming price (plus allowances)  
 There will be no claiming in the series finals  
 SDI reserves the right to cancel any event if sufficient nominations (16) are not received.
